Storage Yard- Joyce Wetzel

Hope everyone is having a safe & happy summer! It has definitely been great weather for the pools!

I recently received a new batch of stickers from the Office that If not already done, will be putting on your items within the next couple of days. I am also setting up a distribution in my computer so if something comes up that I need to address with everyone, I will be able to send out a "blast" email. While I am in the process of setting this up, you may receive one or two "test" emails.

The Yard needs some TLC especially in the weed and clutter departments. Take a look around your area and see if you need to spray those weeds or have clutter that needs to be gotten rid of or just organized. There are several examples on the Internet of weed kill that you can make at home with items you most likely already have or if you are not a computer person, let me know and I will print them out for you. Also, there are a couple of boats/vehicles that may fall into the category of #9 below. If your item(s) fall into that category, please take the necessary steps to either get it fixed or "spruce" it up.

I had the occasion to call an owner about something that was in his spot but not reflected on his Registration Form. When you fill out your form, if there is a possibility that something will be stored in your slot within the upcoming year, please list it on your form. If it is on your form, I will get a sticker for it and won't have to bother you at home if something shows up in your slot that is not stickered.

As a reminder, (These were copied verbatim from our ECC Guidelines on the Assateague Pointe Website)

- 1- It is the Homeowner's responsibility to spray and/or weed their assigned slip in the Storage Area
- 2- The Storage Area is open to Boats, wave-runners, motor homes, storage trailers, vans, golf arts, pick-up trucks and autos.....NO COMMERCIAL VEHICLES ALLOWED
- 3- Only one Storage Area slip will be assigned to a Lot
- 4- No Boats, Trailers, etc., can be stored in a storage slip assigned to another Lot
- 5- No subletting of a storage slip allowed to a 3rd party for a fee or not
- 6- Slips may be loaned to a 3rd party on a temporary basis be not to exceed 7 days
- 7- If an assigned slip occupant is found to have violated these guidelines, their storage slip will be forfeited
- 8- Renters, visitors and guests are NOT allowed to bring in Boats, Trailers, RVs, etc.
- 9- No abandoned, inoperable vehicles, or items in a state of dis-repair are allowed
- 10- Boats may be docked for reasonable short periods of time a the Pier, a two-hour limit should be considered

ECC Committee- George Akers

The ECC has inspected the exterior of every home, shed, property and most golf carts throughout the summer. Most property owners keep their property clean, attractive and in good condition. Unfortunately, there are a few property owners that have not. For those property owners that did not comply with the first request of the ECC, a second inspection was done at the end of July and another letter documenting the problem(s) was mailed to each property owner out of compliance. A third and final inspection will be done at the end of August. If at that time no effort has been made to bring the aforementioned property into compliance, a monetary citation request will be presented to the BOD. It is ultimately up to the BOD to issue a monetary citation. Those property owners out of compliance have the right to appeal that decision.

It is appreciated if every property owner has a legible house number on display. This is important because in the event of the need for emergency services, personnel can find the home. It also helps the ECC do our job.

You must also have your lot number and registration sticker posted on your golf cart. If you received a letter from the ECC regarding the absence of your house number or golf cart registration sticker, you have until the end of August to add that information to your property. Golf Cart registration stickers are available in the main office. Reflective, stick on numbers work well for the lot number display.

It is a reminder to all homeowners that you will need ECC approval for anything significant that you add or change to the exterior of your home. If you are not sure about your addition, change, replacement or repair, please check with the ECC or refer to the ECC guidelines located in the last section of the blue Assateague Pointe manual. This will enable you to stay in compliance with our guidelines. ECC forms and applications are available under communications on our web site. When making changes or additions, please include a detailed drawing and specifications with your application. This will help expedite your request. This includes HVAC systems because it is important that the Assateague Pointe electrician can review the new system specifications before you proceed. It is also a good idea to check with the Worcester County zoning and permits office before proceeding with major projects. Their number is (410) 632-1200.

Several inquiries have been made to the ECC about replacing asphalt shingle roofs with a metal roof. Metal roofs are currently prohibited in Assateague Pointe but The BOD is currently researching the possibility of allowing them. That information will be posted when it becomes available.

A reminder that no wood burning fire pits are allowed. Sparks and flying embers can be a safety hazard. Propane appliances are permitted.
