Description of services:

The initiative will support start-up expenses and bed per night costs for recovery housing of Pregnant Women and Women with Children (PWWC). The successful applicant would be expected to provide a safe, stable, and supportive environment for women who are in early recovery from a substance use disorder and have at least one child in their custody; pregnant women may also qualify.

Funds will be awarded to one successful bidder. The successful applicant will be expected to operate a recovery residence that meets the national recommendations for recovery housing identified by the National Alliance for Recovery Residences (NARR) and the BHA standards for Supportive Recovery Housing for Women with Dependent Children. The successful applicant must demonstrate the ability to meet said national recommendations and BHA standards before accepting residents.

Qualifications of Bidders:

Applicants must meet all of the below-listed eligibility criteria to be considered for funding:

List specific eligibility criteria:

- Ability to start-up a recovery house for PWWC within 60 days of contract award
- Experience managing supportive housing for PWWC
- Experience linking PWWC to community based BH treatment and related supportive services

PART I - SOLICITATION INFORMATION AND INSTRUCTIONS

General:

The Cecil County Health Department, A unit of the Maryland Department of Health, hereinafter called the Department, desires competitive sealed proposals for the purpose of obtaining the service(s) described in PART II of this solicitation.

Delivery of Proposals:

For any type of direct (non-mail) delivery, bidders are advised to secure a dated, signed, and time-stamped (or otherwise indicated) receipt of delivery. Proposal Format:

Proposals must address the following areas:

Proposal Submission Cover Page

All proposals must include the Proposal Cover Page included in this RFP. An electronic copy in MS Word format may be obtained by contacting the Procurement Officer.

Description of Consultant/Organization

Provide a background of the offeror, citing information demonstrating the ability to meet the eligibility requirements outlined in the Key Information Summary Page Qualifications of Bidders.

Proposal Narrative

The proposal narrative shall delineate how the offeror will achieve the goals and objectives outlined in Section II.

Budget

Two detailed budgets must be submitted on the forms provided in APPENDIX C. The first budget will be awarded on a cost reimbursement basis and must detail the costs associated with the start-up of a PWWC recovery house. The second budget will be awarded on a fixed unit price basis and must detail the number of available beds multiplied by bed days, multiplied by the estimated number of clients anticipated to be served through the end of June 2024.

The selected vendor is eligible for up to \$180,000 in start-up funding. Said funding will support purchase of furniture and items necessary for the start-up of a recovery residence. *Submissions requesting funding in excess of \$180,000 will not be considered. Recovery House start-up funds awarded must be spent by 3/14/2024. Funds may not be carried over beyond the term of the contract; therefore, the budget shall include only expenses which will be incurred by 3/14/24.*

The selected vendor is eligible for \$34 per night, per enrolled participant, living in the recovery residence. (Not to exceed \$225,636 during the contract period) *Submissions requesting funding in excess of \$225,636 will not be considered. Funds may not be carried over beyond the term of the contract; therefore, the budget shall include only expenses which will be incurred by 6/30/2024.*

Prior to commencing work on this contract, the Contractor shall provide the Department with a Certificate of Insurance for itself and any subcontractor under the agreement covering claims arising from the operations and provided under the contract. These insurance coverages shall include the following, as well as any insurance as necessary and required by the U.S. Longshoremen's and Harbor Worker' Compensation Act, the Federal Employers' Liability Act, and any other applicable statute:

- a. The statutory limit for Worker's Compensation coverage;
- b. Broad Form Comprehensive General Liability Insurance with a minimum bodily injury limit of \$300,000 for each person and \$500,000 aggregate for each.
- c. Professional Liability Insurance with a minimum limit of \$1,000,000 per incident and \$3,000,000 aggregate for each occurrence; and
- d. Automobile Liability, if applicable.

All coverage shall be provided by insurance companies licensed to do business in the State of Maryland and shall be endorsed to provide 30-day notice of cancellation or non-renewal to the Department's Procurement Officer. All insurance shall be in an amount and type acceptable to the State of Maryland. Any self-insurance program must be documented including any necessary regulatory approval. The Contractor will name the State of Maryland as an Additional Named Insured on all liability policies (Workers' Compensation excepted).

Additional Proposal Submission Requirements:

The bidder shall submit one copy of the following with each proposal submission:

Proposal Affidavit

All bidders must complete and submit, with their Proposal, the Proposal Affidavit attached hereto. Proposals that do not include the Proposal Affidavit may be considered nonresponsive and rejected by the Procurement Officer.

Proof of Fiscal Integrity

The Bidder shall provide the most current annual report to stockholders and/or any documentation that indicates corporate and/or other financial resources that will permit the bidder to fulfill the terms of this IFB. This documentation may include but is not limited to, one or all of the following:

- a. Dunn and Bradstreet Ratings
- b. Audited Financial Statements
- c. Line(s) of Credit
- d. Successful financial track record
- e. Adequate Working Capital

Legal Action Summary

The Bidder shall provide a Legal Action Summary that includes:

- a. A statement as to whether there are any outstanding legal actions or potential claims against the bidder and a brief description of any such action.
- b. A brief description of any settled or closed legal actions or claims against the bidder over the past five (5) years.
- c. A description of any judgments against the Offeror within the past five (5) years, including the case name, number court, and what the final ruling or determination was from the court.
- d. In instances where litigation is ongoing and the bidder has been directed not to disclose information by the court, provide the name of the judge and location of the court.

Past State Experience

As part of its offer, each Bidder is to provide a list of all contracts, with any entity of the State of Maryland, that it is currently performing or which have been completed within the last 5 years.

For each identified contract the Bidder is to provide:

- The State contracting entity
- A brief description of the services/goods provided
- The dollar value of the contract
- The term of the contract
- The State employee contact person (name, title, telephone number and if possible e-mail address)

Minority Business Enterprise (MBE) Affidavits and Documentation

If the bidder is a Minority Business Enterprise, official MBE documentation must be included with the proposal.

Contract Award:

The contract will be awarded to the bidder proposing the best comprehensive plan, budget, and acceptable project timeline who is deemed to have the most demonstrated experience in developing and implementing the requested services.

Grant funds will support (A) costs associated with starting a recovery house for PWWC; and (B) reimbursement for recovery housing for PWWC in residence with a bed cost of \$34.00 per night.

PART II – SPECIFIC REQUIREMENTS/DELIVERABLES OF PROPOSED CONTRACT SPECIFICATIONS

Background:

The Maryland Behavioral Health Administration and Cecil County Health Department seek to expand local support for Pregnant Women and Women with Children (PWWC) in early recovery from a substance use disorder. The successful bidder for the current project would be expected to provide a safe, stable, and supportive environment for women who are in early recovery from a substance use disorder and have at least one child in their custody; pregnant women may also qualify. This temporary living arrangement offers residents a secure atmosphere to rebuild their lives while developing the necessary skills to embark on a life of recovery. Participation is based on individual needs and the ability to follow the requirements of the program.

Vendor requirements:

Offerors must have the capacity to meet the eligibility criteria outlined on the Key Information Summary Page, Qualifications of Bidders.

The successful applicant will operate a recovery residence that meets the national recommendations for recovery housing identified by the National Alliance for Recovery Residences (NARR) and the BHA standards for Supportive Recovery Housing for Women with Dependent Children.

The successful applicant will ensure that admission to RHPWWC is not denied based on participation in medication for opioid use disorder treatment (MOUD), limited work history, or lack of income.

Scope of Services:

The successful applicant will provide a plan and demonstrate the ability to initiate a recovery housing program for PWWC. The successful applicant will launch said program within sixty days of the contract award.

The successful applicant will: (a) document the screening process that helps maintain a safe and supportive environment for women with children; (b) allow family to remain together during the recovery process; (c) document the process that allows children from ages 0-18 to stay with their mother; (d) ensure that the residence is free from alcohol use and/or illicit substance use; (e) assist the Cecil County Health Department toward documenting housing outcomes for program participants upon discharge and up to 3 months thereafter, and (f) assist the Cecil County Health Department in preparing weekly and monthly reports (including a weekly census) for the Maryland Behavioral Health Administration.

Content of Proposals:

Proposal should document development plan, proposed launch date of, and anticipated start-up expenditures for a Cecil County PWWC recovery housing program.

PART III -- GENERAL SOLICITATION AND PROPOSAL PROVISIONS

- A. The Department of Health reserves the right to cancel this solicitation or reject any or all proposals, in whole or in part, to waive minor irregularities in proposals, or to allow the bidder to correct a minor irregularity if the best interest of the State will be served by doing so (COMAR 21.06.02).
- B. All proposals become the property of the Department of Health. Neither the Department nor the State of Maryland shall be responsible for any expenses incurred by the bidders in preparing or submitting their proposals.
- C. All bidders shall acknowledge the receipt of all amendments, addenda, and changes issued in connection with this solicitation.
- D. Proposals may be modified or withdrawn by written notice received in the office designated in this Solicitation before the time and date set for the opening. If expressly permitted in the invitation for proposals, notification of modification or withdrawal may be made by electronic means only in the manner specified in the invitation for proposals.
- E.
 - 1. A Proposal, request to withdraw a Proposal, or a modification to a Proposal is late if it is not received by the Department at the place and by the date and time specified on page 1 of this Solicitation.
 - 2. A late Proposal, late modification, or late request for withdrawal shall not be considered. Exceptions may be made when a late Proposal is received before contract award, and the Proposal, the modification, or withdrawal would have been timely but for the action or inaction of State personnel directing the procurement activity or their employees. A late modification of a successful Proposal, which makes its terms more favorable to the State, shall be considered at any time it is received and may be accepted.
- F. All bidders must complete and submit with their Proposal the Proposal Affidavit attached hereto as APPENDIX A.
- G. Unless otherwise specified under PART II of this solicitation, this contract shall be awarded to the responsive and responsible bidder submitting the most favorable proposal.
- H. In the case of tie proposals, the award will be made in accordance with COMAR 21.05.02.14, unless another tie breaker is defined under Section II of this document.
- I. Bidders should give specific attention to the identification of those portions of their proposal that they deem to be confidential, proprietary information, or trade secrets and provide any justification of why this information should not be disclosed under the Annotated Code of Maryland, §§ 10-611 through 10-630 of the State Government Article. Bidders are advised that, upon request for this information from a third party, the Department is required to make an independent determination as to whether the

information may or must be divulged to the party. Bidders are further advised that proposals will be opened publicly unless specifically stated otherwise in Section II (see COMAR 21.05.02.11 and 21.05.02.17).

- J. Any bidder or other interested person who is aggrieved by the award of the contract resulting from this solicitation may protest that decision. If a protest is made, it shall be in accordance with the procedures set forth at COMAR 21.10.02.03. and 04.
- K. The State reserves the right to make the award by item, group of items, or total Proposal if it is in the best interest of the State to do so, unless the bidder specifies in its Proposal that a partial or progressive award is not acceptable. Note: this may render the Proposal non-responsive.
- L. Although Maryland law does not authorize procuring agencies to favor resident Bidders in awarding procurement contracts, many other states do grant their resident businesses preference over Maryland contractors. Therefore, as described in COMAR 21.05.01.04, a resident business preference will be given if: a responsible Bidder whose headquarters, principal base of operations, or principal site that will primarily provide the services required under this INVITATION FOR PROPOSALS is in another state submits the most advantageous Proposal; the other state gives a preference to its residents through law, policy, or practice; and, the preference to be applied to the contract award herein does not conflict with a Federal law or grant affecting the procurement contract. The preference given shall be identical to the preference that the other state, through law, policy or practice gives to its residents.

 - (e) Promptly inform the appropriate law enforcement agency of every drug-related crime that occurs in its workplace if the business has observed the violation or otherwise has reliable information that a violation has occurred;
 - (f) Establish drug and alcohol abuse awareness programs to inform its employees about:
 - (i) The dangers of drug and alcohol abuse in the workplace;
 - (ii) The business' policy of maintaining a drug and alcohol free workplace;

- (iii) Any available drug and alcohol counseling, rehabilitation, and employee assistance programs; and
- (iv) The penalties that may be imposed upon employees who abuse drugs and alcohol in the workplace;
- (g) Provide all employees engaged in the performance of the contract with a copy of the statement required by §K(2)(b), above;
- (h) Notify its employees in the statement required by §K(2)(b), above, that as a condition of continued employment on the contract, the employee shall:
 - (i) Abide by the terms of the statement; and
 - (ii) Notify the employer of any criminal drug or alcohol abuse conviction for an offense occurring in the workplace not later than 5 days after a conviction;
- (i) Notify the procurement officer within 10 days after receiving notice under §K(2)(h)(ii), above, or otherwise receiving actual notice of a conviction;
- (j) Within 30 days after receiving notice under §K(2)(h)(ii), above, or otherwise receiving actual notice of a conviction, impose either of the following sanctions or remedial measures on any employee who is convicted of a drug or alcohol abuse offense occurring in the workplace:
 - (i) Take appropriate personnel action against an employee, up to and including termination; or
 - (ii) Require an employee to satisfactorily participate in a bona fide drug or alcohol abuse assistance or rehabilitation program; and
- (k) Make a good faith effort to maintain a drug and alcohol free workplace through implementation of §K(2)(a)—(j), above.
- (3) If the business is an individual, the individual shall certify and agree as set forth in §K(4), below, that the individual shall not engage in the unlawful manufacture, distribution, dispensing, possession, or use of drugs or the abuse of drugs or alcohol in the performance of the contract.
- (4) I acknowledge and agree that:
 - (a) The award of the contract is conditional upon compliance with COMAR 21.11.08 and this certification;
 - (b) The violation of the provisions of COMAR 21.11.08 or this certification shall be cause to suspend payments under, or terminate the contract for default under COMAR 21.07.01.11

or 21.07.03.15, as applicable; and

- (c) The violation of the provisions of COMAR 21.11.08 or this certification in connection with the contract may, in the exercise of the discretion of the Board of Public Works, result in suspension and debarment of the business under COMAR 21.08.03.

Standard Addendum for the Means of Delivering Proposals

Any proposal due to any unit of the Maryland Department of Health shall be delivered / transmitted as described in this addendum. The failure of any bidder or offeror to follow these instructions may result in its Proposal or offer not being received by the due time and date, which will result in the rejection of that Proposal or offer.

There are three acceptable means of delivering/transmitting a Proposal or offer:

1. The United States Postal Service;
2. Hand delivery by the bidder/offeror itself; and
3. Hand delivery by a commercial delivery/courier company acting as an agent of the bidder/offeror.

The detailed manner for the utilization of each of these methods is described below:

For U. S. Postal Service Deliveries

For U.S. Postal Service deliveries, any proposal that has been received at the appropriate mail room or typical place of mail receipt for the respective procuring unit by the time and date listed in the RFP or specifications will be deemed to be timely.

If a vendor chooses to use the United States Postal Service for delivery, the Department recommends that it use Express Mail, Priority Mail, or Certified Mail only.

These are the only forms of U.S. Postal Delivery for which both the date and time of receipt can be verified by the Department. A vendor using first class mail will, therefore, not be able to prove a timely delivery at the mailroom. It may take several days for an item sent by first class mail to make its way by normal internal mail pickup to a procuring unit's Proposal box.

**For Hand Deliveries by Vendors and Deliveries
By Commercial Courier Services**

These deliveries must be delivered directly to the room or location specified in the RFP or solicitation and placed in the designated Proposal box. A bidder who uses a commercial courier service must take appropriate action to ensure that the courier actually delivers the Proposal/offer to the specified location and not to the Department's mailroom or loading dock. The Proposal/offer will not be deemed to have been received until it is placed in the designated Proposal box.

For any type of hand delivery, the vendor or its commercial courier services should request a signed receipt from a procuring unit employee which notes the title of the procurement, the name of the vendor, and the time and date of receipt at the Proposal box.

Identifying Information

All envelopes containing proposals or offers, no matter how transmitted, must contain this information prominently displayed:

- either "Sealed Bid" or "Sealed Proposal," as appropriate;
- the exact title of the bid or proposal as noted in the RFP or specifications;
- the due time and date; and
- the name of the bidder/offeror.

Questions on any of these requirements should be directed to the Department contact person identified in the RFP.
