 - -her meeting with Rich Garrahan of La Vida restaurant group went well and is the promising first step in a partnership. La Vida is donating to items for the live auction and offered their tented event space up for the Center whenever it is not in use. La Vida may want to sponsor a table.
 - -she is still awaiting a response from Gary's.

 - -Meoli and Jack Lingo declined sponsorships.
