6:00-6:15 pm — Welcome

- Claire Simmers, CAC Chair
- Christophe Tulou, Executive Director, Delaware Center for the Inland Bays
 He first talked about his background and connections to the CIB. In 1994 he was on the
 Board of Directors and worked on first CCMP. He also was on CIB Board as DNREC
 secretary. It is fortuitous that he returns to the CIB to celebrate 30 years of the CIB in
 2024.

He then provided some general comments for CAC – having citizens' inputs are incredibly important. State of Bays report gives collective opportunities to chart the future with creative ideas and funding will follow. The CIB will develop the resources needed. The action words are – climate change - climate change - climate change. It is critical to build resilience and create a strong defense against ravages of climate change to protect our valuable resources. Investments in doing better in all critical areas will have payback.

 - Directly manage farmland preservation program
 - In Delaware there are 525,000 acres of farmland. 1 in 8 jobs is in agriculture; 8.9 billion in economic activity
 - Provided overview of land use and land use change in Delaware; DE fourth in nation farmland lost to development (low density development in Sussex County due to proximity)
 - Farmland Preservation Program (1991). Governed by Aglands Preservation Foundation; board appointed by governor.
 - Entirely voluntary; 2-step process: enroll in farm Agriculture District for 10 years and then can part of preservation easement.
 - Appraising 360 (35,000 acres) farms this year; fair market value and agricultural value.
 - Select farms ranked by discount until run out of money
 - Total Easement Costs: \$265 million (\$181 million from State)
 - Preserved 148,124 acres (40,843 acres of forested acres).
 - Preserved 7,300 acres in Inland Bays Watershed
 - Landscape preservation (several linked parcels in one area)
 - Environmental wins:
 - Climate smart ag practices: cover crops; conservation tillage; other climate-smart farm practices

• Carbon mitigation strategy

Young Farmer Load Program: buy land with no-interest loan; getting agricultural easement.

 NRCS pays to restore the hydrology on private property and then pays the property
 owner for the development rights; Wetland Restoration Criteria and Guidelines.
 Recreate swallow wetland areas. Various eligibility criteria. Potential to utilize this
 program.
- Inflation Reduction Act (IRA)

Target landowners before put on market

Restoration will stay.

Lots of federal money; needs help in getting the word out about this.

- Work with many partners; conservation is very important for a variety of financial, health & well-being, environmental, recreational etc. reasons
- Included in CCMP in CM2-4 easement and acquisition
 - 3 Goals: Funding; Partnerships; Property Identification
 - Two main groups: Sussex Conservation Partnership and Delaware Land Protection Coalition
- Sussex Conservation Partnership finding land
 - Sussex County key partner
 - How to do direct outreach in addition to what is available on the market
 - Michelle discussed several examples of land acquisitions. Conaway Road (4 acres; will become part of DNREC wildlife management area).
 - Not much land inventory, so question is how to become a bigger buyer of land
- Delaware Land Protection Coalition funding and partnerships
 - Membership is growing

- Delaware Open Space Program (DNREC) protected 64,000 acres throughout the state
- Got money from Bond Bill add'l \$10m for a total of \$20m. A major effort in 2023 is to ask for permanent funding and an increase rather than be part of the Bond Bill.
- 2nd annual Conservation Day at Legislative Hall May 10, 2023 11-4. Details forthcoming, but Save-the-Date.

7:15-7:30pm – Citizens' Inputs

- Bob Clark Beaches are not being protected from development
 - Roads are so clogged and more houses are being developed.
 - DNREC not responsive
 - Developers are a problem, for example, Freeman bought land and recreational boating being harmed directly and indirectly with less land and filling in the marshes with construction spoilage.
 - Dredging is being done causing issues with spoilage; Marshlands being filled in and destroying the environment Seal Island needs to be restored.
- Nick do developers have to do anything additional for conservation beyond paying transfer/realty tax? No, but voluntary efforts do happen
- Susan Anderheggen former resident of CT where she worked with a Land Trust group. She wanted to reinforce to focus on contiguous land and start early to recruit landowners.
