

Mustang Lakes (Annex) Public Improvement District
Phase #2 – Lot Type 2 – 74 Ft Lot
Project Overview

Mustang Lakes (Annex) Public Improvement District (the “District”) was created by the City of Celina City Council on August 13, 2019, pursuant to the Public Improvement District Assessment Act, Texas Local Government Code, Chapter 372, as amended (the “Act”), and Resolution No. 2019-45R upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for assessment by the District.

The District was created principally to finance certain public improvements (the “Authorized Improvements”) that specially benefit assessed property in the District. All of the property in the District is located within the boundaries of the City of Celina (the “City”). On June 10, 2025 the City Council adopted an ordinance that approved a Service and Assessment Plan for the District (the "Service and Assessment Plan") and levied special assessments (the "Phase #2 Assessments") on certain property within Phase #2 the District in accordance with the Assessment Roll attached as Appendix I and Appendix J to the Service and Assessment Plan. The Phase #2 Assessments may be prepaid in whole or in part at any time or may be paid in annual installments as provided by the Act and the Service and Assessment Plan.

The City approved the Phase #2 Initial Improvements Reimbursement Agreement (the “Phase #2 Initial Improvements Reimbursement Agreement”) in the aggregate amount of \$13,317,466 and the Phase #2 Additional Improvements Reimbursement Agreement (the Phase #2 Additional Improvements Reimbursement Agreement”) in the aggregate amount of \$2,548,247 pursuant to the Act, and an ordinance adopted by the City Council on June 10, 2025. The Phase #2 Initial Improvements Reimbursement Agreement and Phase #2 Additional Improvements Reimbursement Agreement are payable from the Assessments levied against each parcel of Assessed Property within the District pursuant to the Phase #2 Assessment Ordinances and in accordance with the Service and Assessment Plan.

All Assessments that are not paid in full will be billed in annual installments and collected each year by the City, or its designee, as provided in the Service and Assessment Plan. Annual Installments are due and payable as provided on the annual installment assessment bill. **Annual Installments are billed by the Collin County Tax Office and are due and payable as provided on the annual installment assessment bill.** Annual installments are expected to be billed and collected on the same schedule as property taxes. The Assessments, including the annual installments thereof, are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or other political subdivision ad valorem property taxes, whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.

The exact amount of each annual installment will be approved each year by the City Council in the Annual Service Plan Update for the District. - 1 - Example: The Annual Installment for Year 2025 will be billed on or around 10/1/2025 and payment is due by 1/31/2026.
- 2 - The principal and interest amounts represent the estimated debt service requirements of the Phase #2 Initial Improvements Reimbursement Agreement and will not increase during the life of the Reimbursement Agreement. Interest amounts are calculated through the principal payment date of each year.
- 3 - The principal and interest amounts represent the estimated debt service requirements of the Phase #2 Additional Improvements Reimbursement Agreement and will not increase during the life of the Reimbursement Agreement. Interest amounts are calculated through the principal payment date of each year.
- 4 - Administrative Expenses are estimated and will be updated each year in the Annual Service Plan Update.

THIS SCHEDULE IS AN ESTIMATE OF ANNUAL INSTALLMENT PAYMENTS AND IS SUBJECT TO CHANGE. THE EXACT AMOUNT OF EACH ANNUAL INSTALLMENT WILL BE REFLECTED IN THE MUSTANG LAKES (ANNEX) PUBLIC IMPROVEMENT DISTRICT ANNUAL SERVICE PLAN UPDATES. Property Owners may choose to prepay their Assessment at any time. Effective January 1, 2024, for any single-family residential parcel prepaying an Assessment, a \$500 fee will be included in the total payoff amount to cover processing and other lien release related filing expenses.
