

Hillstone Pointe Public Improvement District No. 2
Phase #2-3 – Lot Type 1 – 50 Ft.

Project Overview

The Hillstone Pointe Public Improvement District No. 2 (the “District”) was created by the Town of Little Elm Town Council (“Town Council”) on April 4, 2017, pursuant to the Public Improvement District Assessment Act, Texas Local Government Code, Chapter 372, as amended (the “Act”), and Resolution No. 04041709 upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for assessment by the District.

The District was created principally to finance certain public improvements (the “Authorized Improvements”) that specially benefit assessed property in the District. All of the property in the District was located within the Town of Little Elm (the “Town”) at the time of District creation. On December 19, 2017, the Town Council adopted Ordinance No. 1438 that approved a Service and Assessment Plan for the District (the “Service and Assessment Plan”) and levied special assessments (the “Phase #2-3 Assessments”) on certain property within Phase #2-3 in accordance with the Phase #2-3 Assessment Roll attached as Appendix B to the Service and Assessment Plan. The Phase #2-3 Assessments may be prepaid in whole or in part at any time or may be paid in annual installments as provided by the Act and the Service and Assessment Plan.

The Town issued the Town of Little Elm Special Assessment Revenue Bonds, Series 2018 (Hillstone Pointe Public Improvement District No. 2 Phase #2-3 Project) in the aggregate amount of \$4,688,000 pursuant to the Act, Ordinance No. 1471 adopted by the Town Council on November 6, 2018 and an Indenture of Trust dated as of December 1, 2018 between the Town and U.S. Bank National Association, as trustee.

All Phase #2-3 Assessments that are not paid in full will be billed in annual installments and collected each year by the Town, or its designee, as provided in the Service and Assessment Plan. **Annual Installments are billed by the Denton County Tax Office and are due and payable as provided on the annual installment assessment bill.** Annual installments are expected to be billed and collected on the same schedule as property taxes; however, annual installments may be billed separately from property taxes and remitted to a different address than property taxes. The Phase #2-3 Assessments, including the annual installments thereof, are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or other political subdivision ad valorem property taxes, whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.

The exact amount of each annual installment will be approved each year by the City Council in the Annual Service Plan Update for the District. - 1 - The Annual Installment billed during Year 2025 will be billed by the Denton County Tax Office on or around 10/01/25 and payment is due by 01/31/26.

2 - The principal and interest amounts represent the final numbers of the Series 2018 Bonds and will not increase during the life of the bonds. Interest amounts are calculated through the principal payment date each year and include additional interest of one-half of one percent for debt service reserves.

3 - The Administrative Expenses are estimated and will be updated each year in the Annual Service Plan Updates.

THIS SCHEDULE IS AN ESTIMATE OF ANNUAL INSTALLMENT PAYMENTS AND IS SUBJECT TO CHANGE. Property Owners may choose to prepay their Assessment at any time. Effective January 1, 2024, for any single-family residential parcel prepaying an Assessment, a \$500 fee will be included in the total payoff amount to cover processing and other lien release related filing expenses.
