### League City Public Improvement District No. 1 (Magnolia Creek)

#### **Project Overview**

League City Public Improvement District No. 1 (the "District") was created by the City Council of the City of League City, Texas (the "City") on November 18, 1997, pursuant to the Public Improvement District Act, Texas Local Government Code, Chapter 372, as amended (the "Act"), and Resolution No. 97-66 upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for Assessment by the District.

The District was created principally to finance certain public improvement projects for the residential and commercial development located within the City. A Service and Assessment Plan was accepted and approved by the City Council on December 14, 1999 setting forth the plan for apportioning the costs of certain of the public improvement projects (the "Authorized Improvements") to be assessed against properties in the District and for payment of Assessments with respect thereto.

The City and Mag Creek LP. And MHWS (the "Developers") entered into Public Improvement District Development and Financing Agreements, under which the Developers are entitled to repayment of the funds advanced for the construction of the Public Improvements. The Public Improvement District Development and Financing Agreement obligations are secured by the Assessments levied on properties within Phase 1, 2, 3, 5, 5B, and 13 of the District.

All Assessments that are not paid in full will be billed in annual installments and collected each year by the City, or its designee, as provided in the Service and Assessment Plan. Annual Installments are anticipated to be billed by the Galveston County Tax Office and will be due and payable as provided on the annual installment assessment bill. Annual Installments are expected to be billed and collected on the same schedule as property taxes. The Assessments, including the annual installments thereof, are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or other political subdivision ad valorem property taxes, whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.
