## The Woodlands Public Improvement District Major Improvement Area

### **Project Overview**

The Woodlands Public Improvement District (the "District") was created by the Commissioners Court of Medina County, Texas (the "County") on March 26, 2021, pursuant to the Public Improvement District Act, Texas Local Government Code, Subchapter A of Chapter 372, as amended (the "PID Act"), and Resolution No. 6711 upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for Assessment by the District.

The District was created principally to finance certain public improvement projects for the residential development located within the boundaries of the County of Medina. A Service and Assessment Plan was accepted and approved by the County on May 11, 2021, pursuant to Order No. 2021-03-11-02 (the "Assessment Order"), setting forth the plan for apportioning the costs of certain of the public improvement projects (the "Authorized Improvements") to be assessed against properties in the District and for payment of Special Assessments with respect thereto.

The County issued the Medina County, Texas Special Assessment Revenue Bonds, Series 2021 (Woodlands Public Improvement District Major Improvement Area Project) (the "MIA Bonds") in the aggregate principal amount of \$4,700,000 pursuant to the Act, an Order No. 2021-03-11-04 adopted by the Commissioners Court on March 11, 2021 and an Indenture of Trust dated as of March 1, 2021 between the County, and the UMB Bank, N.A. as trustee.

The MIA #1 Authorized Improvements are payable from Assessments levied against each parcel of property within the MIA of the District pursuant to the Assessment Ordinance adopted by the City Council. Annual Installments are anticipated to be billed by the Medina County Tax Office and are due and payable as provided on the annual installment assessment bill. The PID Act provides that the Special Assessments (including any reassessment, the expense of collection and reasonable attorney's fees, if incurred) are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or municipality ad valorem property taxes whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.
