River Ridge Public Improvement District Project Overview Improvement Area #2 – Lot Type 1 – 60 FT Lot

The River Ridge Public Improvement District (the "District") was created by the City of Crandall City Council (the "City Council") on June 1, 2020, pursuant to the Public Improvement District Assessment Act, Texas Local Government Code, Chapter 372, as amended (the "Act"), and Resolution No. 060120 upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for assessment by the District.

The District was created principally to finance certain public improvements (the "Authorized Improvements") that specially benefit assessed property in the District. All of the property in the District is located within "River Ridge North" (the "Development") of Crandall (the "City") at the time of District creation.

The City issued the City of Crandall, Texas, Special Assessment Revenue Bonds, Series 2022 (River Ridge Public Improvement District Major Improvement Area Project) (the "Series 2022 Bonds") in the aggregate amount of \$5,453,000 pursuant to the Act, Ordinance No. 101722E adopted by the City Council on October 17, 2022 and an Indenture of Trust dated as of November 1, 2022 between the City and Wilmington Trust, National Association, as trustee. Improvement Area #2 Parcels has a proportionate share of the Series 2022 Major Improvement Area Bonds to finance the cost of the Major Authorized Improvements.

On February 18, 2025, the City approved issuance of the City of Crandall, Texas Special Assessment Revenue Bonds, Series 2025 (River Ridge Public Improvement District Improvement Area #2 Project) (the "Improvement Area #2 Bonds") in the aggregate principal amount of \$17,398,000 to finance, refinance, provide or otherwise assist in the acquisition, construction and maintenance of the public improvements provided for the benefit of the property in the PID. The Improvement Area #2 Bonds are secured by the Improvement Area #2 Assessments (the "Improvement Area #2 Assessments").

The Series 2025 Bonds are payable from the Assessments levied against each parcel of Assessed Property within the District pursuant to the Assessment Ordinance and in accordance with the Service and Assessment Plan. Additionally, as more fully described in the Service and Assessment Plan, the City has approved the Reinvestment Zone Number One, City of Crandall Reimbursement Agreement (the "TIRZ No. 1 Reimbursement Agreement") relating to the River Ridge development. The City and Kaufman County (the "County") have agreed, subject to the terms of the TIRZ No. 1 Reimbursement Agreement, to apply, respectively, 65% and 50% of the annual City and County ad valorem taxes collected for this property as an offset against the following year's Annual Installment of the Assessment. Pursuant to the Updated Service and Assessment Plan and the TIRZ No. 1 Reimbursement Agreement, the TIRZ Annual Credit Amount shall not cause the overall tax rate, including City, County, Road and Bridge, Trinity Valley Community College, and Crandall ISD tax rates, and Annual Installments on a Parcel, to fall below \$3.0737 per \$100 of ad valorem taxable value, if feasible (the "PID Residential Assessment Paydown Rate").

All Assessments that are not paid in full will be billed in annual installments and collected each year by the City, or its designee, as provided in the Service and Assessment Plan. <u>Annual Installments are billed by the Kaufman County Tax Office and are due and payable as provided on the annual installment assessment bill.</u> Annual installments are expected to be billed and collected on the same schedule as property taxes. The Assessments, including the annual installments thereof, are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or other political subdivision ad valorem property taxes, whether now

or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.

Effective January 1, 2024, for any single-family residential parcel prepaying an Assessment, a \$500 fee will be included in the total payoff amount to cover processing and other lien release related filing expenses. River Ridge Public Improvement District (PID) & Reinvestment Zone No. 1 (TIRZ)

The property in the PID is also located in the City of Crandall Tax Increment Reinvestment Zone No. 1. The City of Crandall and Kaufman County have committed to use a portion of their annual incremental ad valorem property taxes collected from a property in the current tax year as a credit (the "TIRZ Credit") to reduce the PID annual installment of assessments due in the following year. Pursuant to the Updated Service and Assessment Plan and the TIRZ No. 1 Reimbursement Agreement, the TIRZ Annual Credit Amount shall not cause the overall tax rate, including City, County, Road and Bridge, Trinity Valley Community College, and Crandall ISD tax rates, and Annual Installments on a Parcel, to fall below \$3.0737 per \$100 of ad valorem taxable value, if feasible (the "PID Residential Assessment Paydown Rate").

If a property owner is to receive a TIRZ Credit, the Annual Installment shown on their tax statement will be the projected Annual Installment shown in the attached schedule **LESS** any TIRZ Credit.
