

**North Grove Public Improvement District
Improvement Area #1
Project – Lot Size – All**

Project Overview

The North Grove Public Improvement District (the “District”) was created by the City of Waxahachie City Council on July 24, 2014, pursuant to the Public Improvement District Assessment Act, Texas Local Government Code, Chapter 372, as amended (the “Act”), and Resolution No. 1189 upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for assessment by the District.

The District was created principally to finance certain public improvements (the “Authorized Improvements”) that specially benefit assessed property in the District. All of the property in the District is located within the corporate limits of the City of Waxahachie (the “City”). On February 26, 2015, the City Council adopted Ordinance No. 2783 that approved an updated Service and Assessment Plan for Improvement Area #1 of the District (the "Original Service and Assessment Plan") and levied special assessments for Improvement Area #1 (the "Improvement Area #1 Assessments") on certain property within Improvement Area #1 of the District in accordance with the Assessment Roll attached as Appendix A to the Original Service and Assessment Plan. The Assessments may be prepaid in whole or in part at any time or may be paid in annual installments as provided by the Act and the Service and Assessment Plan.

The City issued the City of Waxahachie (North Grove Public Improvement District Improvement Area #1 Project) Special Assessment Revenue Bonds, Series 2015 (the “IA #1 Bonds”) in the aggregate amount of \$6,675,000 pursuant to the Act, an Ordinance adopted by the City Council on February 26, 2015 and an Indenture of Trust dated as of March 1, 2015 between the City, and the Wilmington Trust N.A. as trustee. Parcels within Improvement Area #1 (the “IA #1”) of the District were levied \$6,675,000 for costs of the IA #1 Authorized Improvements.

All Assessments that are not paid in full will be billed in annual installments and collected each year by the City, or its designee, as provided in the Service and Assessment Plan. **Annual Installments are billed by the Ellis County Tax Office and are due and payable as provided on the annual installment assessment bill.** Annual installments are expected to be billed and collected on the same schedule as property taxes. The Assessments, including the annual installments thereof, are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or other political subdivision ad valorem property taxes, whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.

The exact amount of the assessment may be obtained from the City. The exact amount of each annual installment will be approved each year by the City Council in the Annual Service Plan Update for the District.
