

**Celina 241 Public Improvement District
Improvement Area #1 – Lot Type 1 – 60 FT Lot
Project Overview**

The Celina 241 Public Improvement District (the “District”) was created by the City Council of the City of Celina (the “City Council”) on March 11, 2025, pursuant to the Public Improvement District Act, Texas Local Government Code, Chapter 372, as amended (the “Act”), and Resolution No. 2025-18R upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for assessment by the District. All of the property in the District is located within the boundaries of the City of Celina (the “City”).

The District was created principally to finance certain public improvement projects (the “Authorized Improvements”) that specially benefit assessed property in the District. On August 11, 2026, the City Council approved an ordinance (the “Assessment Ordinance”) accepting and approving a service and assessment plan for the District (the “SAP”) and levying special assessments (the “Improvement Area #1 Assessments”) against the Improvement Area #1 Assessed Property as shown on the Improvement Area #1 Assessment Roll attached to the SAP. The Improvement Area #1 Assessments may be prepaid in whole or in part at any time without penalty or may be paid in Annual Installments as provided by the Act and the SAP.

The City issued the City of Celina (Celina 241 Public Improvement District Improvement Area #1 Project) Special Assessment Revenue Bonds, Series 2026 in the aggregate amount of \$14,346,000 pursuant to the Act, in Ordinance 2026-076 (the “Bond Ordinance”) adopted by the City Council on August 11, 2026, and an Indenture of Trust dated as of September 1, 2026, between the City, and the U.S. Bank, N.A. as trustee.

The Series 2026 Bonds are payable from the Improvement Area #1 Assessments levied against each parcel of Assessed Property within Improvement Area #1 of the District pursuant to the Assessment Ordinance and in accordance with the SAP.

All Assessments that are not paid in full will be billed in annual installments and collected each year by the City, or its designee, as provided in the Service and Assessment Plan. **Annual Installments are billed by the Collin County Tax Office and are due and payable as provided on the annual installment assessment bill.** Annual installments are expected to be billed and collected on the same schedule as property taxes. The Assessments, including the annual installments thereof, are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or other political subdivision ad valorem property taxes, whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.

1 - The Annual Installment billed during Year 2026 will be billed by the Collin County Tax Office on or around 10/01/26 and payment is due by 01/31/27.

2 - The principal and interest amounts are based on the Improvement Area #1 Series 2026 Bonds and will not be increased during the life of the bonds.

Interest amounts are calculated through the principal payment date each year and include additional interest of one-half of one percent for debt service reserves.

3 - The Administrative Expenses shown include the estimated District administration and assessment collection costs and will be updated each year in the Annual Service Plan update.

THIS SCHEDULE IS AN ESTIMATE OF ANNUAL INSTALLMENT PAYMENTS AND IS SUBJECT TO CHANGE. THE EXACT AMOUNT OF EACH ANNUAL INSTALLMENT WILL BE REFLECTED IN THE CELINA 241 PUBLIC IMPROVEMENT DISTRICT SERVICE AND ASSESSMENT PLAN, AS THE SAME IS UPDATED EACH YEAR.

Property Owners may choose to prepay their Assessment at any time. Effective January 1, 2024, for any single-family residential parcel prepaying an Assessment, a \$500 fee will be included in the total payoff amount to cover processing and other lien release related filing expenses.
