

Waxahachie Public Improvement District No. 1
Phase #4 - Lot Type 3 - 60 Ft.

Project Overview

Waxahachie Public Improvement District No. 1 (the “District”) was created by the City Council of the City of Waxahachie, Texas (the “City Council” and the “City” respectively) on April 16, 2007, pursuant to the Public Improvement District Assessment Act, Texas Local Government Code, Chapter 372, as amended (the “Act”), and Resolution No. 1087 upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for assessment by the District.

The District was created principally to finance certain public improvements (the “Authorized Improvements”) that specially benefit assessed property in the District. All of the property in the District was located within the corporate limits of the City. On September 15, 2025, the City Council adopted Ordinance No. 3672 that approved an updated Service and Assessment Plan for Phase #4 of the District (the “Service and Assessment Plan”) and levied special assessments (the “Assessments”) on certain property within the District in accordance with the Assessment Roll attached as Appendix C-4, to the Service and Assessment Plan. The Assessments may be prepaid in whole or in part at any time or may be paid in annual installments as provided by the Act and the Service and Assessment Plan.

The City executed a reimbursement agreement for the Waxahachie Public Improvement District No. 1 – Phase #4 District Improvements in the aggregate amount of \$2,034,190 pursuant to the Act.

The City issued the Special Assessment Revenue Bonds, Series 2026 (Waxahachie Public Improvement District No. 1 Phase Four-Five Project) (the “Phase #4-5 Bonds”) in the aggregate amount of \$3,312,000 pursuant to the Act, Ordinance No. 3736 adopted by the City Council on July 20, 2026 and an Indenture of Trust dated as of August 1, 2026 between the City and UMB Bank, N.A. as trustee. A portion of the Phase #4-5 Bonds were approved to acquire the Phase #4 Reimbursement Agreement Obligation in the original amount of \$2,034,190 to hereby finance the remaining cost of the Authorized Improvements in Phase #4.

All Assessments that are not paid in full will be billed in annual installments and collected each year by the City, or its designee, as provided in the Service and Assessment Plan. **Annual Installments are billed by the Ellis County Tax Office and are due and payable as provided on the annual installment assessment bill.** Annual installments are expected to be billed and collected on the same schedule as property taxes. The Assessments, including the annual installments thereof, are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or other political subdivision ad valorem property taxes, whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.

- 1 - Example: The Annual Installment for Year 2026 will be billed by the Ellis County Tax Office on or around 10/01/2026 and payment is due by 1/31/2027.
- 2 - The principal and interest amounts represent the final numbers of the Series 2026 Bonds and will not increase during the life of the bonds. Interest amounts are calculated through the principal payment date of each year.
- 3 - Annual Collection Costs are estimated and will be updated each year in the Annual Service Plan Updates.
- 4 - Prepayment and Delinquency Reserve amounts collected represent an additional 0.5% interest as allowed by the PID Act.

THIS SCHEDULE IS AN ESTIMATE OF ANNUAL INSTALLMENT PAYMENTS AND IS SUBJECT TO CHANGE. THE EXACT AMOUNT OF EACH ANNUAL INSTALLMENT WILL BE REFLECTED IN THE WAXAHACHIE PUBLIC IMPROVEMENT DISTRICT NO. 1 SERVICE AND ASSESSMENT PLAN, AS THE SAME IS UPDATED EACH YEAR.

Property Owners may choose to prepay their Assessment at any time. Effective January 1, 2024, for any single-family residential parcel prepaying an Assessment, a \$500 fee will be included in the total payoff amount to cover processing and other lien release related filing expenses.
