

**Foree Ranch Public Improvement District
Improvement Area #1 (Phase #1)
Lot Type 1 – 50 Ft.**

Project Overview

The Foree Ranch Public Improvement District (the “District”) was created by the Town of Providence Village Town Council on September 6, 2022, pursuant to the Public Improvement District Assessment Act, Texas Local Government Code, Chapter 372, as amended (the “Act”), and Resolution 2022-253 upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for assessment by the District.

The District was created principally to finance certain public improvements (the “Authorized Improvements”) that specially benefit assessed property in the District, all of which is located within the corporate limits of the Town. On March 19, 2024, the Town Council adopted Ordinance 2024-290 that approved a Service and Assessment Plan for Improvement Area #1 of the District (the “Service and Assessment Plan”) and levied Special Assessments (the “Improvement Area #1 Assessments”) on certain property within Improvement Area #1 in accordance with the Improvement Area #1 Assessment Roll attached as Appendix G to the Service and Assessment Plan. The Improvement Area #1 Assessments may be prepaid in whole or in part at any time or may be paid in annual installments as provided by the Act and the Service and Assessment Plan.

The Town and Developer entered into a Reimbursement Agreement (the “Omnibus Reimbursement Agreement”) of which Improvement Area #1’s pro-rata portion of the principal amount payable to the Developer is \$7,085,000 (the “Improvement Area #1 Reimbursement Agreement Obligation”). The Improvement Area #1 Reimbursement Agreement Obligation will finance the Actual Costs of a portion of the Authorized Improvements being constructed for the Property. The Property is expected to be developed in multiple phases. For each phase developed, the Town will levy and collect Assessments for the benefitted Property pursuant to multiple Assessment Ordinances.

On August 6, 2024, the Town issued the Town of Providence Village, Texas Special Assessment Revenue Bonds, Series 2024 (Foree Ranch Public Improvement District Project) (the “Foree Ranch Series 2024 Bonds”) in the aggregate amount of \$7,027,000 pursuant to the Act, Ordinance No. 2024-300 to replace the Improvement Area #1 Reimbursement Agreement Obligation and is backed by the Improvement Area #1 Assessments.

All Assessments that are not paid in full will be billed in annual installments and collected each year by the Town, or its designee, as provided in the Service and Assessment Plan. **Annual Installments are billed by the Denton County Tax Office and are due and payable as provided on the annual installment assessment bill.** Annual installments are expected to be billed and collected on the same schedule as property taxes. The Assessments, including the annual installments thereof, are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or other political subdivision ad valorem property taxes, whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.

- 1 - Annual Installment billing will commence during Year 2026 and will be billed on or around October of 2026 and payment is due by January 31, 2027.
- 2 - The principal and interest amounts represent the final numbers of the Foree Ranch Series 2024 Bonds and will not increase during the life of the bonds. Interest amounts are calculated through the principal payment date of each year and include additional interest of one-half of one percent for debt service reserves.
- 3 - Administrative Expenses are estimated and will be updated each year in the Annual Service Plan Updates.

THIS SCHEDULE IS AN ESTIMATE OF ANNUAL INSTALLMENT PAYMENTS AND IS SUBJECT TO CHANGE. THE EXACT AMOUNT OF EACH ANNUAL INSTALLMENT WILL BE REFLECTED IN THE FOREE RANCH PUBLIC IMPROVEMENT DISTRICT ANNUAL SERVICE AND ASSESSMENT PLAN UPDATES.
