

**Eastridge Public Improvement District
Improvement Area #1 – Lot Type 40 FT**

Project Overview

Eastridge Public Improvement District (the “District”) was created by the City Council of the City of Princeton (the “City Council” and the “City” respectively) on June 14, 2021, pursuant to the Public Improvement District Assessment Act, Texas Local Government Code, Chapter 372, as amended (the “Act”), and Resolution No. 2021-06-14-R-01 upon petition of the owners of the taxable real property representing more than 50 percent of the appraised value of taxable real property liable for assessment within the District and the property owners who own taxable real property that constitutes more than 50 percent of the area of all taxable real property that is liable for assessment by the District.

The District was created principally to finance certain public improvements (the “Authorized Improvements”) that specially benefit assessed property in the District. All of the property in the District was located within the corporate limits of the City. On July 25, 2022, the City Council adopted Ordinance No. 2022-07-25 that approved a Service and Assessment Plan for the District (the "Service and Assessment Plan") and levied special assessments (the "Assessments") on certain property within the District in accordance with the Assessment Roll attached as Appendix A, to the Service and Assessment Plan. The Assessments may be prepaid in whole or in part at any time or may be paid in annual installments as provided by the Act and the Service and Assessment Plan.

The City issued the Special Assessment Revenue Bonds, Series 2022 in the aggregate amount of \$11,209,000 pursuant to the Act, Ordinance No. 2022-07-25-02 adopted by the City Council on July 25, 2022 and an Indenture of Trust dated as of August 1, 2022 between the City and Regions Bank.

All Assessments that are not paid in full will be billed in annual installments and collected each year by the City, or its designee, as provided in the Service and Assessment Plan. **Annual Installments are billed by the Collin County Tax Office and are due and payable as provided on the annual installment assessment bill.** Annual installments are expected to be billed and collected on the same schedule as property taxes. The Assessments, including the annual installments thereof, are (a) a first and prior lien against the property assessed, superior to all other liens and claims except liens or claims for state, county, school district or other political subdivision ad valorem property taxes, whether now or hereafter payable, and (b) a personal liability of and charge against the owners of the property to the extent of their ownership regardless of whether the owners are named.

The exact amount of the assessment may be obtained from the City. The exact amount of each annual installment will be approved each year by the City Council in the Annual Service Plan Update for the District. - 1 - Annual Installment billed by the Collin County Tax Office during Year 2026 will be billed on or around 10/01/26 and payment is due by 1/31/27.
- 2 - The principal and interest amounts represent the debt service requirements of the Series 2022 Bonds and will not increase during the life of the Bonds. Interest amounts are calculated through the principal payment date each year and include additional interest of one-half of one percent for debt service reserves.
- 3 - Administrative expenses are estimated and will be updated each year in the Annual Service Plan Update.

THIS SCHEDULE IS AN ESTIMATE OF ANNUAL INSTALLMENT PAYMENTS AND IS SUBJECT TO CHANGE. THE EXACT AMOUNT OF EACH ANNUAL INSTALLMENT WILL BE REFLECTED IN THE EASTRIDGE PUBLIC IMPROVEMENT DISTRICT SERVICE AND ASSESSMENT PLAN, AS THE SAME IS UPDATED EACH YEAR.

Property Owners may choose to prepay their Assessment at any time. Effective January 1, 2024, for any single-family residential parcel prepaying an Assessment, a \$500 fee will be included in the total payoff amount to cover processing and other lien release related filing expenses. Example of TIRZ Credit Application

The property in the PID is also located in the City of Princeton Tax Increment Reinvestment Zone No. 3. The City has committed to use up to approximately 45% of the annual incremental City ad valorem property taxes collected from a property in the current tax year as a credit (the "TIRZ Credit") to reduce the PID annual installment of assessments due in the following year. The following **hypothetical example** illustrates the application of the TIRZ Credit:

A) Estimates for illustration purposes:

Estimated prorated base year (2024) taxable value = \$1,000

Estimated current year (2026) taxable value = \$417,500

Estimated current (2026) incremental value = \$416,500 (i.e. \$417,500 - \$1,000)

Estimated current (2026) City tax rate per \$100 of taxable value = \$0.549999

Estimated PID current (2026) annual installment of Assessment = \$3,307

Estimated PID next (2027) annual installment of Assessments = \$3,336

B) **Estimated** City incremental tax:

\$2,288 [i.e., $(416,500 \div 100) \times \$.549999 = \$2,288$]

C) **Estimated** TIRZ Credit:

\$1,030 (i.e., $\$2,288 \times 45 \% = \$1,030$)

D) PID current annual installment due (2026):

\$3,307 with no prior year TIRZ Credit

E) **Estimated** PID next annual installment due (2027):

\$2,306 (i.e., $\$3,336 - \$1,030 = \$2,306$) after application of the \$1,030 TIRZ Credit

The maximum annual TIRZ Annual Credit amount ("Maximum Annual TIRZ Credit") for any Parcel with a completed home and fully appraised with improvements prior to 2025 will be capped at the annual TIRZ Credit amount that was shown in the 2025 Annual Service Plan Update for such Parcels. For any Parcel with a home that was not completed and fully appraised in 2025 or afterwards, the Maximum Annual TIRZ Credit amount will be capped at the tax increments generated the first year following the completion and full appraisal of the home on such Parcel.

PLEASE NOTE THAT THE ABOVE CALCULATIONS ARE ONLY INTENDED TO ILLUSTRATE APPLICATION OF THE TIRZ CREDIT AND DO NOT REPRESENT ANY ACTUAL OR PROJECTED AMOUNTS OF TAXABLE VALUES, CITY TAX RATES AND PID ANNUAL INSTALLMENTS.
