Additionally, the Government Relations Committee participates in weekly Zoom sessions with our lobbyist, Dennis Rasmussen, to stay abreast of any changes or action that needs to be taken. We also work closely with our elected officials and strengthen relationships with other statewide legislators that have similar priorities in their districts.

[Oppose HB0506: Grocery Beer & Wine Sales](#)

Support our local retailers that currently provide alcoholic beverage sales by opposing this bill. This bill will establish that, on or after a certain date, a retail grocery establishment in the state may obtain a license authorizing the retail grocery establishment to sell beer and wine to individuals who are at least 21.
