INTRODUCTION

These guidelines are designed to allow expansion of restaurant service temporarily to outdoor areas not previously used by a business – this might include seating expansion onto sidewalks, parking areas, or other open areas on site. In order to support local business, the County and Board of License Commissioners intend to review and expedite outdoor dining requests on a case-by-case basis.

All restaurants who desire to modify their service areas to locations not previously approved shall complete the following application and provide all relevant attestations and information to the Department of Planning and Zoning (DPZ). DPZ shall serve as expediter or ombudsman and assist the business in navigating the approval process from a Health Department, Fire Marshall, Planning and Zoning, and Board of License Commissioners, and any other building or other life safety code perspective. Sufficient detail must be provided such that relevant Departments can determine the location, layout, and affected site features of the temporary extension and affirm that the arrangement comports with protection of the public safety, health, and welfare. There will be no fees for these reviews and each Department will make every effort to complete required reviews within two business days of submission.
