II. LMB Updates & Reports:

A. Executive Committee

The Executive Committee met on January 9, 2024. The Executive Board reviewed today's agenda and did not make decisions that will require full ratification by the Board.

B. Secretary

Katie Dilley, President, presented the October 18, 2023 minutes and the Retreat meeting minutes from November 16, 2023, for approval.

**Action:

Jone Taylor moved to approve the October 18, 2023 and November 16, 2023 minutes as written. Gail Lundberg provided a second. All present voted in favor with no abstentions and the motion was carried.

C. Treasurer

Colleen Thomas, Treasurer, presented the Treasurer's Reports for November and December 2023, for approval.

**Action:

Jone Taylor made a motion to accept the Treasurer's Reports for November and December as written. Matt Evans provided a second. All present voted in favor to accept the Treasurer's Reports for November and December 2023 with no abstentions, and the motion was carried.

- The June board meeting is rescheduled to June 12, 2024 at 11:30 a.m., due to the holiday.
 - Bylaws Approval
 - Staff is working on edits to the bylaws.
 - The bylaws with edits will be forwarded to the board for their review and will be voted upon at the February meeting.
 - Update Consortium on Coordinated Community Supports
 - Substantial amount of movement since June.
 - 2 large requests for proposals.
 - A review panel has been organized to review the applications.
 - 1st round was released in August –Spokes.
 - Funding to add health services in public schools only.
 - Seven applications, that were endorsed by QACPS, were submitted for QAC, requesting \$10.8 million.
 - 260 applications received state-wide, requesting \$360 million.
 - Only \$120 million state-wide earmarked for Spokes.
 - A lot of work to scale back what they are supporting.
 - The following partners have been recommended to be advanced for further consideration:
 - Hazel Health
 - Choptank Community
 - Striving for Wellness
 - Chesapeake Bay Psychological
 - The midshore counties as a whole:
 - 25 applications submitted, totaling \$29.4 million.
 - Out of those 25 applications, 13 applications were advanced for further consideration totaling \$5.6 million.
 - Approximately \$24 million that was not supported.

- Working to propose a regional pilot Hub structure for all five midshore counties.
- At this point MSBH submitted an application to represent 4 of the 5 counties as a Hub. Caroline County is not participating in the Hub program.
- Providing incentives to join the Hub.

 - Jacki Carter Award applications are out in the schools.
