PIT Counts - Leslie Leether	PIT (Point in Time) count is meant to serve as a snapshot of homelessness in the community and provides a sense of the overall scope of homelessness in our area and America. HUD requires CoCs to do a count of people experiencing homelessness who are unsheltered, sheltered in emergency shelters, in transitional housing, and in safe havens on a single night. This year's PIT count will be on 01/29/2025. This year the concern is for Wicomico County as they do not have the staff to help with the count. After some discussion, the group would like to have a
