Chrysalis House Robin Rickard	 What is Chrysalis House? Provides substance use and mental health treatment services to women 18 years of age and older. Women with children AND women without children are eligible .Children allowed to live onsite during mother's program of recovery. One of four residential treatment centers that allow women to bring their children with them. Located in Crownsville, Maryland and serves women across the state. Only accepts clients with Medicaid insurance Chrysalis House Crownsville: Residential Treatment Program ❖ Chrysalis House Healthy Start Program .Transitional/Recovery Housing: Aftercare in four supportive homes in the area.

Chrysalis House - Crownsville

❖ Be at least 18 years of age. Have a primary diagnosis of chemical addiction. Have completed a detoxification program and be drug- and alcohol-free for a minimum of 5 days prior to admission Clients may bring up to two children under age 10 at time of admission.

Chrysalis House Healthy Start

Serves Maryland residents who are pregnant or with one child under age 3 with a history of substance use disorder and/or mental health issues. Provides safe and sober living in a healing environment - St. Ambrose Church in. Baltimore's Park Heights neighborhood Provides resources and referrals to achieve goals. Services: Recovery Capital Assessment, Individual-Centered Service Plan, Behavioral. Health Therapy, Prenatal Care/Mother & Child Doctor Visits, Circle of Security-Parenting Training, Life Skills Education and Training, Case Management, In-House AA Meetings, Childcare, Scheduled Transportation (business hours), Safe and Secure Private Living Space

Transitional/Recovery Housing

- Must be at least 18 years of age. Must have recently completed a treatment program and be detoxed. Must be able to live independently with minimal supervision. Must be enrolled in an aftercare program. Attend 12 step meetings regularly (available on-site at (Crownsville)Diagnosed with substance abuse as a primary condition Enrolled in Access to Recovery program.

Agency Updates/ Upcoming Trainings	Claudia Nelson-(DSS)- They are still having services at the Crisfield library every Thursday from 10:30-3. Mostly handling Food Stamps, TANF, and Child Support. DSS will be moving from the Crisfield Library to an office inside the Woodrow Wilson building sometime in the beginning of 2025. Cherie Meienschein (Recovery Court)- Increase in Family Law Clinic that is on Fridays till noon and is now also available on Wednesdays twice a month. Edwana Cottman (TidalHealth)- As you may have already heard there is a merger happening soon with AGH. There will be no major changes with this merger. Now they have a psychiatrist at the Ocean Pines Berlin location. Hoping to have a 2nd therapist soon. Sherry Hostetler (ESCJA)- Is partnering with local law enforcement, promoting crisis intervention training for the officers. We now have two part-time people who are helping bridge the gap to get more referrals, which she feels is making a personal connection and helping the referral process. There have already been 4 officers signed up for the training.
