We are on track to meet that goal 2. Obtain a license for SCHD to be able to facilitate CCSMP/DSMP classes - a. We have obtained the License 3. Have 6 individuals trained to teach the class. a. Aves and myself took the last two spots for this session b. will be getting 4 more to complete the training once			

	another class is scheduled. ● We have purchased Food Lion gift cards as an incentive to get people to be screened and assessed as part of HEALTH. ● Mobile Integrated Health Team - Still low participation but we haven't started getting the CAD referrals from EMS yet. The participation rate is also low because many of the people that are being referred are refusing to participate. We are hoping that the addition of the gift cards will act as an incentive to increase participation.
