- VI.** Swearing-In New Election Board Member – Commissioner Shelley Johnson Sworn in Mr. James Holbrook as an Election Board Member making the 5th Member of the Election Board.
- VII.** Ordinance #2025-03 Section 131- Solid Waste/ADOPTION – Commissioner Gardner motioned for the Ordinance/Second by Commissioner Polk – Commissioner Johnson also voted yes! (3-VOTES YES). AYES have it.
- VIII.** Critical Area Ordinance Amendment #2025-04 - First Reading/INTRODUCTION – Town Manager Jay Prouse read the report written by Henry Eure went over at our last meeting – House Bill 233 which was passed by the state general assembly requires all local jurisdictions including the town of Princess Anne to review and update the critical area program at the rate not to receive every 10 years. The most recent update occurred in April of 2012, so a couple years behind, and the town was overdue for the update. Earlier this year, the state of Maryland's Department of Natural Resources Critical Area Commission began working with town staff to update the code and bring it up to compliance. As required by the town's code, the proposed amendments were reviewed by the planning commission at their September 18th, 2025 meeting where a favorable recommendation was made to adopt the amendments as written. In addition, the amendments have been reviewed by the town's attorney and found to be acceptable. Unless there's any questions, you have the documents in front of you. The state mandates that and from Henry everything is in play and ready this will be the first reading and introduction and then what we'll do is, once you vote to move forward, we'll do a second reading at our work session and adopt it. Commissioner Johnson – The finance department just announced that our audit has been extended until October or November. So, we will not be making any decisions until we know exactly how much money we have.
